- Excelled academically with an overall minimum cumulative grade point average of 3.0 (based on a maximum of 4.0) or its equivalent. The nominee shall be evaluated upon all academic work completed through the first semester of their senior year in high school.

- 4. A letter of recommendation (from a non-family member) who is over the age of 21 and can attest to the applicant's performance in school, community, or through a charity.

Finalists will be required to partake in a Zoom interview as the last step in the process. Winners will be chosen subjectively by a special committee comprised of Sponsor's employees and/or salespersons. Winners will be notified via email and/ or text. Scholarship checks will be made payable directly to the recipients' Registrar's Office institution. If the scholarship cannot be used "in-full" for tuition, then the scholarship will be forfeited and awarded to another applicant.
